- Violating copyright laws.
- Using another user's account and password.
- Damaging computers, personal or network files.
- Trespassing in another user's private files.
- Attempting to circumvent network security.
- "Cyber-bullying".
- Using the OUSD-Net for commercial purposes or individual financial gain.

Unless otherwise instructed by school personnel, students shall not disclose, use, or disseminate personal identification information about themselves or others when using email, chat rooms, or other forms of direct electronic communication. Students are also cautioned not to disclose such information by other means to individuals contacted through the Internet without the permission of their parents/guardians. Personal information includes the student's name, address, telephone number, Social Security number, Adoress or other individually identifiable information
